



Thank you for choosing Wish Newport, LLC as your partner in consigning. Here is how it works:

### **Inventory Requirements**

Wish is an upscale designer consignment boutique. Only couture and designer women's clothing is accepted, including select casual wear, formal wear, and designer accessories (e.g. shoes, handbags, and jewelry). A guide to the brands generally consigned by Wish is available on our website. Wish will no longer accept suits, unless they have a genuine, contemporary twist. Wish DOES NOT ACCEPT bridesmaid or wedding gowns, men's, or juniors clothing. Wish does accept a small amount of children's clothing to existing womenswear consignors.

All items shall be in excellent, new or like-new, condition and currently in season when received.

All items shall be laundered, pressed, and neatly folded (not in garbage bags). We will not accept any item that contains spots, defects, tears, odors, or other damage. All gowns should be dry-cleaned by the consignor and hanger ready.

We do not accept designer replicas. All items are authenticated prior to listing them for sale. Wish may want to have an existing relationship with a consignor before accepting highly replicated items such as designer handbags.

When you bring your items in, we will carefully select items based on their condition, style, desirability of brand, and season. Please understand that sometimes there may be items that we decline or will not be able to sell.

We price each item based on brand, market value, condition and customer demand.

### **Consignment Appointments**

Wish requires all consignors to schedule appointments by email, prior to bringing in their items. These appointments are necessary in order to provide the utmost care and attention to consignor's valuable items.

★ *We ask that you make a list of the items that you bring in for consignment and remove items we do not accept from your list after the appointment.*

Upon a successful consignment appointment, wish® shall establish a personalized consignor account with the consignor's name and each item consigned shall be labeled and itemized. An itemized list of items and initial pricing will be emailed to the consignor on the day the items enter the sales floor.

Prices are set based on comparative items, condition, original value, and market prices.

Note: Keep in mind that with deeper discounts being taken at department stores and retailers (e.g. Marshalls, TJ Maxx, EBay, etc.) for NEW items, consigned items must be competitively priced under those price points.

\_\_\_\_\_ **Consignment Term:** The consignment period is 90 days from the date the items are listed for sale. Wish will email the consignor an itemized and priced list on the start date. At the end of the consignment period, consignors will have a 14 day period after the contract end date to schedule a pick up time (48 hours' notice required) to claim any unsold items. It is the consigners responsibility to remember their contract end date. Items not picked up within 30 days of the contract end date become property of Wish. Please note expiration date on emailed copy of agreement. **(EXAMPLE: START DATE: 1/1/17 -> EXPIRATION DATE: 4/1/17 -> SCHEDULE PICKUP BY: 4/15/17 -> ITEMS BECOME WISH PROPERTY: 5/1/17)**

\_\_\_\_\_ **Price Reductions:** Items are progressively reduced. After 30 days: 20% & After 60 days: 50% All items are also subject to sales, promotions or other discounts Wish may offer.

\_\_\_\_\_ **Payment:** The consigner will receive 50% of the selling price, via check or store credit. Consignors shopping with store credit at Wish will receive an additional 10% off their purchases. Consignor payouts are available for pick up on the 15th of every month for items sold the previous month. Please request check by the 10<sup>th</sup> of the month. Out of state consignor checks can be mailed by specific request. Checks must be cashed within 90 days from the date cut or they will be null and void. Wish is not responsible for address updates on our client's behalf or for mail lost by the post office.

\_\_\_\_\_ **Liability:** Wish will take exceptional care of consignor's items; however, merchandise is left at your own risk. Wish is not responsible for loss or damage to my items by handling, fire, theft, accident or any other cause. *We look forward to a long and mutually profitable relationship with you. After all, we could not do it without you!*
